Level 1 Coaches Course (National and Regional) Registration Deadline: Tuesday, February 7th, 2017

The course is open to anyone who wishes to learn more, and to start on the Coaches Pathway. They need to be committed to applying their knowledge and skills to the development of teams and clubs in their nation. <u>Coaches</u> with previous Volleyball/FIVB experience who wish to become involved in Para Sport will be particularly welcome.

All candidates will be expected to participate in practical sessions. The use of numbered shirts is encouraged. However, candidates should not go to the expense of buying a numbered shirt.

- Feedback/Evaluation

Level 1 Referee Course (National and Regional) Registration Deadline: Tuesday, February 7th, 2017

Referees are one cornerstone to the development of the sport and a key element of the foundations. Ideally candidates should have prior knowledge of volleyball but the course is open to anyone with the enthusiasm to become a referee. Referees with experience of Volleyball (National and FIVB) are particularly welcome and should be encouraged. Because of the movement required by Sitting Volleyball referees the role is unfortunately not suited to those in wheelchairs or with considerable movement problems.

The course will include sessions on the following, but not necessarily in this sequence:

- Volleyball for athletes with physical impairment
- Expectations of the Referee
- Introduction on the Role of the Referee & the Referee Code of Conduct
- Referee Match and Event Preparation
- Detailed study of the current Rules of the Game
- Interpretation of the Rules of the Game
- Introduction to Practical Officiating
- Terminology
- Application of Official Hand Signals & Line Judge Signals
- Practice and Evaluation
- Explanation of the Score-sheet
- Score sheet Examination
- A Written Examination
- A Practical Examination

*Candidates will receive either a Level 1 Diploma or a Certificate of Attendance, depending on their performance.

All candidates should bring their own whistle if at all possible and should be prepared to play in practical sessions. Numbered shirts are encouraged for the practical sessions. Candidates should not go to the expense of buying a numbered shirt.

Qualification Requirements

• Qualified National Referees of a high national level who have not reached their 45th birthday on January 23rd, 2017. There can be no exceptions to this age rule.

Level 1 Classification Course (National and Regional) Registration Deadline: Tuesday, February 7th, 2017

Candidates must be Nationally recognised and authorised to practice as a Medical Doctor or Physiotherapist. In the case of a physiotherapist the candidate must have completed a minimum three-year course. Proof of qualification and CV should be forwarded with the Course Registration Form.
